

William C. Bryant Elementary School Parent and Family Engagement Policy

In support of strengthening student academic achievement, William C. Section A: JOINTLY DEVELOPED

William C. Bryant Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Parents are invited to a Spring Title I meeting to review, give feedback and update the Parent and Family Engagement Policy. The meeting was held on April 25, 2023. Parents are encouraged to attend meetings throughout the school year. These meetings give parents the opportunity to review, improve and give feedback on parent and family programs.

- 1- Back to school night Date is set for September 14, 2023. Information is provided to the parents regarding various programs used within the school including iReady and clubs or organizations. Community members present their programs to the parents and staff during this time, which includes but is not limited to assistance for eye glasses and after school programs.
- 2- Class Dojo Used for parent communication as well as being incorporated into our PBIS system. Students received points that are recorded in the system to purchase and receive rewards.
- 3- Robo calls Robo calls are made by the principal, assistant principal, and parent liaison in order to relay important information and dates to parents/guardians. Parents need to ensure that their phone numbers are always up-to-date with the school.
- 4- Monthly Calendars Calendar is created monthly and sent home with students and is also available in the front office. States school activities for students and parent SAC meetings and other school-based information.
- 5- Flyers Flyers are sent out to send reminders of important dates that may be coming up on the monthly calendar or were added.
- 6- Teacher phone calls Teachers are required to keep regular contact with families regarding grades and behavior. These calls will be made as part of the school's behavioral system procedures, but will also include positive phone calls.
- 7- Report card conferences Report card conferences at the end of each marking period. Are held during three half-days and include scheduled times between the teacher and parents. Dates are provided on the monthly calendar. Conferences with parents are scheduled on an as needed basis.
- 8 The SAC meetings will be held at rotating or flexible times (AM and PM) and with an option to attend via Zoom

On April 25, 2023, parents were invited to the Spring Title I Parental Meeting. The school's Title I representative as well as the school's administrators were present for the meeting. On January 17, 2023, parents attended the Winter Title I Meeting, where they were able to review the current school-wide plan and the school budget. Parents provided input based on their needs of how they would like the parent-involvement funds allocated. TI funds were budgeted to buy School Improvement Support Liaison position. This position will focus soley on attendance and communicating with parents on how barriers to attendance can be removed and families can be supported in attending school daily and consistently.

Parents will also learn about the requirements of Title I, Part A, and how to help to monitor their child's progress and how to work with eeucators. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.

Parents will also be provided information about joining the SAC committe and other opportunities for regular meetings for parents to formulate suggestions, and to participate, as appropriate, in decisions about the education of their children.

William C. Bryant Elementary School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

In August as a part of Summer Summit Training, all school staff will be trained by the Administrators and Leadership Team on how to communicate and work with parents as equal partners. Additionally, throughout the school year, the staff will be informed of the results from the parent survey. The Parent Surveys are made available to parents during all events, meetings and conferences.

William C. Bryant Elementary School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- Recognizing parents for their efforts: Recognize all of the efforts made by parents who serve on school advisory committees and in other decision-making roles.
- Providing child development information: Conducting workshops on what parents can expect as their child moves into middle school or high school. Workshop topics may include: "Changes in homework requirements" Communication with your adolescent or teen "Specific issues of parenting the adolescent.
- Surveying parents: Ask parents what information and workshops they would find most helpful. "Consult with parents and others in the community: Ask about their preferences and the best ways to translate or modify messages to all parents.
- Establishing home visiting programs: When teachers visit with parents in the home, teachers can share with them school and classroom expectations, and parents can share information about home situations that might affect student achievement.
- Making referral information readily available: Put referral information on bulletin boards, in newsletters, and on information tables at school events. This information can include times and locations of parenting classes, agency services to families, and parks and recreation schedules. Offer information about parenting that is provided by community agencies and churches.
